It became the springboard for a collaborative project between the Texas Council for the Humanities (now known as Humanities Texas), The Texas Association of Developing Colleges, and the Texas African American Heritage Association to document personal narratives about the coming of school desegregation in Texas communities. *Parallel and Crossover Lives: Texas Before and After Desegregation*, became a pilot community oral history project at Jarvis Christian College in Hawkins and Huston-Tillotson College in Austin.
